WHEREAS to run the said **Darul-uloom** Smoothly and regularly without any disturbance **Darul Ulum** as well as to look after the management and keep an eye over the activity and assets and do work of charitable purpose for the benefit of the general people without discrimination of caste creed, sex and religion, the settlor desires to establish a Educational and Charitable Trust in respect of the said **Darul-uloom Amjadia Quadam Rasool Khagra, Kishanganj** as well as to carry out the objects herein below mentioned and for this the settlor setting a sum of Rs. 1,50,000/- (Rupees One Lac Fifty Thousands only) upon the Educational and Charitable Trust.

AND

WHEREAS the Trustees have agreed to become the Trustees of the said Trust as testified by their being parties to and executing these present and hold apply the said sum of Rs. Rs. 1,50,000/- (Rupees One Lac Fifty Thousands only) and all gifts, donation, contribution, accretions and addition thereto which they will receive and posses and in the name of Trust or on its behalf for the fulfillment of the objects of the Trust as well as **Darul-uloom Amjadia Quadam Rasool Khagra, Kishanganj** as and the settlor also handed over management of the said **Darul-uloom** to the Trustees.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-

1. That the settlor is the absolute owner of a sum of Rs. 1,50,000/- (Rupees One Lac Fifty Thousands only) and hereby conveys, transfers and grants unto the hands of the Trustees named hereinabove to hold the same for the said Trust to carry out the objects and purposes and for wishes of the settlor according to the direction hereinbelow :-
2. That the **NAME** of the Trust shall be **Amjadia Educational and Charitable Trust (in short AECT)**.
3. That the office of the Trust shall be situated at **QUADAM RASOOL, KHAGRA,**

The Trustees shall be at liberty to transfer the office or may open branch or branches at any place/Places within the Territories of India at their mutual decision from time to time.

4. The **OBJECTS** of the Trust are to give benefit to the general people without discrimination of caste, creed, sex and religion.

Without prejudice to the generality of the objects aforesaid, the objects are elaborated here under.

- i) To promote education by establishing educational institution like *Darul-uloom* and public institutions for modern scientific education as well as technical institutions for general people.
- ii) To provide free vocational training by establishing the vocational and technical centers.
- iii) To establish coaching centre for those students who wish to appear in combined test examination held by state Govt, central Govt. and universities. Or other institution.
- iv) To give financial assistance to the poor students to continue their study whether by way of scholarship or one time assistance.
- v) To provide financial assistance to the poor people to meet the funeral expenses, to the parents of poor girls to perform marriage ceremony and to the flood, earthquake victims, and patients suffering from deadly diseases.
- vi) To establish health centers/Hospital for free checkup and to provide medicine to the patients.
- vii) To organize and arrange Blood and eye donation camps.
- viii) To encourage sport and games.
- ix) To publish books, journals, Magazines, periodicals.
- x) To organize from time to time, seminars, workshop, training, symposia, counseling programme etc. on the need spreading all types of education among general people.
- xi) To establish orphanage, old aged home as well as for disabled persons.
- xii) To purchase/acquire the land or building donation/gifts in the name of Trust for the enlistment and fulfillment of the aims and object of the Trust.
- xiii) To establish network with other national or international NGO'S, and funding agencies for the purpose of fulfillment of the object of the Trust.
- xiv) To preserve the identity of religions, Quabristan, minorities, Dalits and to take up action towards ensuring their constitutional, social and economic right.
- xv) To do all other lawful acts, deeds and things as may be necessary, for which this indenture is silent if necessary for the general public.

2. POWER AND FUNCTION

All the Trustees hereinafter collectively called "Board of Trustees" which shall have the following power and functions.

- (i) The Board of Trustees shall have the power to elect President Vice President Secretary & Joint Secretary For such on the board of Trustees may Specify
- (ii) The board of Trustees shall be at liberty to accept any property, contribution, gifts, collection or donation from any person/persons, firm, company or government, private agencies or other institutions for the advancement and fulfillment of the objects of the Trust.
- (iii) The board of Trustees shall be at liberty to sell and/or realize the Trust property or fund and invest the sale proceeds thereof or any other moneys following part of the Trust fund in any manner for the fulfillment of the objects of the Trust.
- (iv) The Board of Trustees may out of the corpus of the Trust spend such money or out of the sale proceeds of any part thereof, appropriate such money or part thereof for all or any of the objects and purposes of the Trust.
- (v) The Board of Trustees may appoint an Auditor, Accountant, Contractor, permanent, part time or honorary staff if necessary for managing or working of the Trust and use the Trust fund for payment of their salaries or expenses etc.
- (vi) It shall be lawful for the Board of Trustees to file withdraw, compromise or compound any action other suit or proceeding in the name of the Trust relating to the Trust and Trust properties. And the Board of Trustees shall be competent to authorize any Trustee to execute, Vakalat-Nama, Letter of Authorities which shall be binding and valid for and on behalf of the Trust.
- (vii) The Board of Trustees shall also be at liberty to take over the management of any other Trust or Institution.
- (viii) The general management and control of the Trust for the purpose of managing the affairs of the Trust, Trust properties and fund and for the purpose of carrying out the objects aforesaid shall be vested in the board of Trustees.
- (ix) The board of Trustees shall have the power to make rules and regulation to carry out and to give effect to the objects and purposes of the

- Trust and/or managing the affairs of the Trust, and to rescind, alter, amend, and add the same from time to time if necessary.
- x) The board Trustees shall have the power to expel/remove any trustee president/ vice president, Secretary & Joint Secretary and employee of the Trust majority if they found guilty they of any activity which is against the object and benefit of the Trust exclude administrators.
- xi) The board of Trustees shall open a Bank account with any nationalized Bank to deposit the Trust fund, and such account shall be operated by its Secretary administrator and any one of the Trustees.
- xii) The board of Trustees shall have the power to constitute a managing committee to carry out any objects, to supervise and have control over the different institution or organization of this Trust. Further the Trustees shall constitute and advisory Board to advise.
- xiii) The board of Trustees shall have the power to delegates its power to any managing committee, constituted by the Trust to carry out the objects of the Trust.
- xiv) The board of Trustees can transfer the management of any institution, organisation, establishment run by the Trust to any committee, such committee or to any person.
- xv) The board of Trustees shall enter into contracts, arrangement for and in connection with any of the object.
- xvi) The board of Trustees shall have the power to raise or borrow money with or without security of any property of the Trust for the fulfillment of the objects. The Board of Trustees, shall have the power to inspect the Annual account and after due inspection and discussion may pass or reject the same.
- xvii) The board of Trustees shall have the power to do any other things which is incidental and conducive to the attainment of the objects or any of them or any objects which are not mentioned here before.
- xviii) The board of the trustees shall have the power to make decision to get loan/any kind of such financial transaction to meet its requirement for benefit of the general people.

xix) The administrator of the trust shall get remuneration as the work discharge by him/her according to the members of the trust decided through its decision making body.

3. MANAGING COMMITTEE

The board of Trustees by majority vote shall have the power to constitute one or more managing committee to carry out the objects of the Trust, to supervise to have control over the function and activities of the different institution run by the Trust.

- i) The Managing committee (s) shall consists of at least five members out of which three members shall be from the Trustees and rest two members will be nominated by the board of Trustees from amongst the dignitaries and luminaries of the society.
- ii) The managing committee shall carry out the tasks as delegated to it from time to time by a resolution of the board of Trustees.
- iii) The managing committee shall be collectively responsible to the board of Trustees.
- iv) Term of the managing committee shall be decided by the board of Trustees.
- v) Qurum of meeting of the managing committee shall be of two members.
- vi) Any members shall be expelled by the board of Trustees.
- vii) The vice president of the Trust shall be its chairman.
- viii) The managing committee shall be dissolved by the board of Trustees if thinks necessary to do it or after the completion of work assigned to it.

7. ADVISORY COMMITTEE

The board of Trustee shall constitute advisory committee consisting of the expert of various fields viz. political dignitaries, social workers, scholars to advise the board of Trustees for such term as the board of Trustees may specify. The advice, suggestions and recommendation shall not be binding upon the board of Trustees.

Secretary of the Trust shall be its convenor who shall convene the meeting of the advisory Board and report its proceedings to the Board of Trustees.

The Trust shall maintain its office at Quadam Rasool Kishanganj (Bihar) where all the books of accounts and other documents of Trust shall be kept. Trust office can be transferred to any other place if so desired by the three fourth (3/4) Trustees. The board of Trustees may open any branch or



office of the Trust and may close the same in any part of the country.

YEAR OF ACCOUNT

The first account of the Trust shall start from the date of its creation to 31st March next. Thereafter accounting year shall start from 1st April and end on 31st March of the next calendar year.

8. DUTIES OF THE TRUSTEES.

1. The Board of Trustees shall wholly be responsible for fulfillment and carrying out the objects of the Trust.
2. A Trustee shall be answerable to the Board of Trustees.
3. All securities and fund, Property shall be kept in the name of the Trust.
4. Any trustee has the right to resign from his Trusteeship after information in writing before 30 days.

9. MEETINGS, QUORUM

- i) The Board shall meet thrice in a year but it may call an emergency meeting as and when necessary.
- ii) Meetings of the Board of Trustees shall be convened by the president of the Trust or by the person authorized by him for this purpose.
- iii) One third (1/3) member of the Trustees shall form the quorum of the meeting. Without forming quorum meeting of the day shall stand adjourn to another date.
- iv) President of the Trust shall preside over the meeting, but in absence of the president the Trustees present in the meeting shall elect a Trustee to preside over the meeting.
- v) All matters discussed in the meeting shall be decided mutually but in case of difference of opinion matter shall be decided by majority of votes of present Trustees at the meeting in case of tie of votes, the matter shall be decided by the vote cast by the president.
- vi) Meeting of the Board of Trustees shall be convened at **QUADAM RASOOL, KHAGRA** or any other place as may be agreed upon by the Board of Trustees or fixed by the president of the Trust.

The Board of Trustees keep the minute Book of the proceeding of its meeting, proper books of account documents and other details of its activities.

10. VACANCIES AND APPOINTMENT

A Trustee shall ceases to be a Trustee.

- a) If he/she dies.
- b) If he/she resigns
- c) If he/she expelled by the Board of Trustees.

2. The Board of Trustees shall have the power to fill the vacancies occurred in the Board of Trustees amongst the

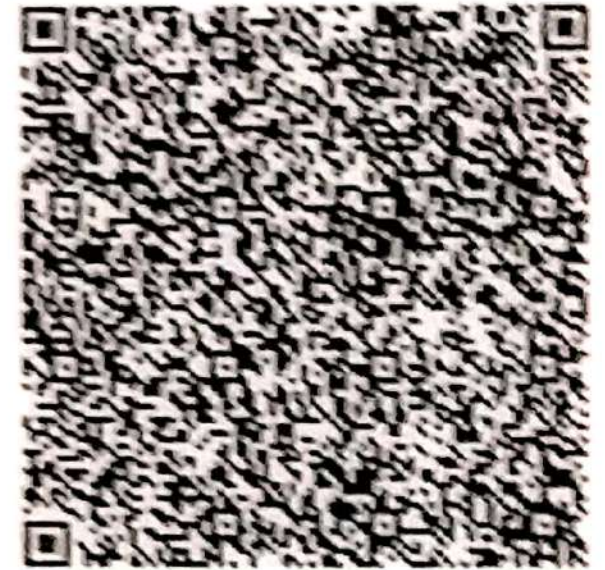
